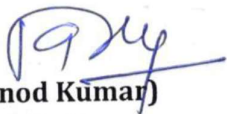
Applications are invited from the eligible students of B.Tech- 2nd year, session 2025-26 for branch change against the vacant seats in the III-semester as per the AKTU regulations. The branch change process will be carried out based on the merit of YGPA obtained in the 1st year, session 2024-25. The interested students can submit their application form (attached) along with a copy of the 1st year result of session 2024-25 in the **Registrar Office**, latest by **14th November 2025**.

The eligibility norms are as follows:

- The students with minimum **6.5 YGPA** or higher in first year without Carry Over Papers and have passed all the subjects in single attempt shall be eligible for branch change.
- The students who are allotted seats in Fee Waiver/EWS Quota will be eligible for branch change only against the respective approved intake in a particular branch.
- Re-admitted/ Ex-student/Lateral Entry/PMSSS student shall not be eligible for branch change.
- The students of the branch, in which the strength of the class is less than 75% of the intake approved by AICTE, shall not be eligible for branch change.
- In case a student has applied for scrutiny/re-evaluation of his/her marks of first or Second semester and the result has not been declared till the time of change of branch, then, such student shall not be entitled to change of branch based on his/her subsequently revised result.

Branch change will be done strictly according to the rules & regulations of AKTU. Once a branch is allotted to the student, then it will not be reverted, hence students are advised to take permission from their parents before applying for branch change.

No Form will be accepted after the last date.
