Change of Branch - B. Tech. 2nd Year, Session 2026-27

Ref: AKTU Circular# ए०के०टी०यू०/परी०नि०का०/2026/शा०परि०/3165 dated 17-August 2026

Applications are invited from eligible B. Tech. 2nd Year students (Batch 2025) for a change of branch against vacant seats in the III Semester (Session 2026–27), in strict adherence to AKTU regulations. Allotment will be made strictly on a merit basis, determined by the Year Grade Point Average (YGPA) secured in the 1st Year (Session 2025–26). If a change of branch is permitted, it will be effective from the third semester of the B.Tech program.

ELIGIBILITY CRITERIA

- 1. Academic Merit:** Minimum YGPA of 6.50 or higher in the 1st year, passed in a single attempt without any Carry Over Papers (COP).
- 2. FW / EWS Quota Seats:** Students admitted under Fee Waiver (FW) or EWS quota may change branches only against vacant seats within their respective approved quota in that specific branch.
- 3. Branch Strength Rule:** Applications cannot be processed from branches where the current strength has fallen below 75% of AICTE intake. After branch change the intake must not be more than approved AKTU for UPTAC counselling intake.
- 4. Re-evaluation Status:** Branch allotment will consider only the declared result on the cutoff date. Subsequent mark revisions will not apply.
- 5. Ineligible Candidates:** Lateral Entry, Re-admitted, Ex-students, and PMSSS scholars are NOT eligible for branch change.

APPLICATION PROCEDURE & DEADLINE:

- **Required Documents:** Duly filled application form (attached) + Self-attested copy of 1st-year result (Session 2025–26).
- **Submission Venue:** Office of the Registrar (E-115)
- **Last Date & Time: 21st August 2026 | 05:00 PM**
