**Date Extension for UP Govt. Scholarship Form submission (Fresh/Renewal),
Session 2025-26**

Keeping in view of technical problems on the UP-Govt. scholarship portal, the last date for submission of the scholarship application form is extended till **26th November 2025**. All the students concerned must fill the online application form (**fresh/renewal**) on the UP-Government scholarship portal and submit hard copy with relevant documents in **Registrar Office (E-115)** latest by **26/11/2025**.

Eligibility Criteria:

1. Student should be **permanent resident of UP** and must have **domicile certificate** and **category certificate in case of OBC/SC/ST**, issued by the District Authorities of UP in his/her name.
2. The annual income of the parents from all sources should be up to **Rs.2,00,000/-** (Rs. Two Lakh only). In the case of students belonging to the **SC/ST category**, the income limit of the parents is **Rs.2,50,000/-** (Rs. Two Lakh Fifty Thousand only). **The income certificate should be in the name of your Father (or Mother, if your father is not alive)** issued by the Distt. Revenue Authorities to that effect is essential for the purpose. **The income certificate in the name of the student will not be accepted, and such forms will be rejected.**
3. Students should have passed last given examination.
4. Student pursuing B. Tech course should not have applied for Scholarship for any graduation course in last years. (The students admitted by way of lateral entry based on B.Sc. are eligible to apply)
5. Students pursuing MCA/ MBA should not have applied for scholarships in any post-graduation (professional) course in last years.
6. **General/OBC/Minority** category students admitted in B. Tech/B. Pharm-1st year must have obtained at least **60%** marks in their INTERMEDIATE (12th) examination.
7. **General/OBC/Minority** category students admitted in MCA/MBA should have obtained minimum 55% marks in their GRADUATION.
8. **GENERAL/SC/ST/Minority** category students should have been admitted through **AKTU COUNSELLING (UPTAC)-2025** (for B Tech/B. Pharm/MBA/MCA) / **JEECUP counseling-2025** (for D. Pharm) based on **JEE-Main/CUET/JEECUP** Examination (as applicable).
9. **General/SC/ST/Minority** category students admitted through **Management Quota/Vacant Seats** are not eligible for UP Govt scholarship.
10. Students who applied for a scholarship to UP Govt during the last year 2024-25, but did not receive a scholarship, are required to apply for a scholarship **renewal only. Do not apply as a fresh.**
11. The students admitted under **FEE WAIVER QUOTA** are not eligible for UP Govt scholarship.
 - **Students belonging to Minority Category (Muslim / Sikh /Jain/ Christian /Neo Budh) are advised to apply under Minority category only. (Even if they are categorized under OBC category). Further, students of minority category are strictly advised to apply only under one scheme (i.e. either under Central Govt. Merit cum Means Scheme for Minority Community (MOMA) or under UP Govt. scheme).**
 - **Submitting false information or forged documents to gain any benefit, including a scholarship, is a serious criminal offense with severe consequences. The students are strongly advised not to take this path.**
 - **If a student applies online and receives a payment but does not apply for renewal in the next year, the student is liable to return the paid amount to the UP gov. In the case of dropping out, the student will also have to return the funds received for the previous year of the course.**
